**Strategic Environment Assessment Screening
May 2021**

Introduction

- 1.1** The purpose of this report is to determine whether or not the contents of the *Air Quality Supplementary Planning Document* (SPD) requires a Strategic Environmental Assessment (SEA) in accordance with the European Directive 2001/42/EC and associated Environmental Assessment of Plans and Programmes Regulations 2004, as amended by The Environmental Assessments and Miscellaneous Planning (Amendment)(EU Exit) Regulations 2018 (the SEA Regs).

Legislative Background

- 1.2** In addition, Paragraph: 008 of the Planning Guidance Reference ID: 11-008-20140306 has been considered. This states that supplementary planning documents may in exceptional circumstances require a strategic environmental assessment if they are likely to have significant environmental effects that have not already been assessed during the preparation of the relevant strategic policies. This screening statement considers the impacts which are not already assessed within the Harrogate District Local Plan Sustainability Appraisal 2018 and the Sustainability Appraisal Addendum 3 Main Modifications July 2019.

Purpose of the SPD

- 1.3** The SPD seeks to provide detailed guidance to support Policy NE1: Air Quality in the Local Plan adopted 4 March 2020 (adopted for new settlement policies on 9 December 2020) . The guidance intends to provide additional background, help and guidance in relation to the policy and assist those who are seeking planning permission where air quality may be a factor. The guidance supports the implementation of the policy and expands on that provided in the National Planning Policy Guidance (NPPG) and the reasoned justification to Policy NE1. The SPD provides clarification of when air quality assessment and dust assessment reports are required, including;
- Where info set out in criteria A-D can be found e.g. AQMAs, Sensitive areas are identified.
 - Setting out thresholds for when significant amount of traffic may be generated using validation criteria
 - Mitigation
 - Assessment
 - Stressing importance of pre-application consultation to include discussions with Environmental Health Officers and NYCC Highways.

Screening Process

- 1.4** The screening opinion assessment is undertaken in two parts: the first will assess whether the SPD requires SEA and the second part of the assessment will consider whether the SPD is likely to have a significant effect on the environment, using criteria drawn from Schedule 1 of the SEA Regulations.

2 Strategic Environmental Assessment (SEA) Screening

The Environmental Assessment of Plans and Programmes Regulations 2004

2.1 The Environmental Assessment of Plans and Programmes Regulations 2004 came into force on 20th July 2004.
