1 Introduction

1 Introduction

Local Green Spaces

- 1.1 The National Planning Policy Framework (NPPF) allows local communities to identify green areas of particular local significance for allocation as Local Green Spaces. This allocation will provide special protection and only allow new development in very special circumstances.
- **1.2** Local Green Space can be allocated within the emerging Harrogate Local Plan or within neighbourhood plans.
- 1.3 The Local Green Space allocations will only be used where a green space is shown to be demonstrably special and of particular significance to the local community. Not all green spaces will be suitable for this type of designation. Existing green spaces which are currently protected and which are not suitable for Local Green Space allocation will continue to be provided protection against development by Policy HP6 of the Draft Local Plan, 'Protection of Existing Sport, Open Space and Recreation Facilities'.

This report

- 1.4 This report provides an update to the previous Local Greenspace Assessment completed in 2016 as part of the evidence base to support the draft Local Green Space Policy and the draft allocations as set out within the draft Harrogate District Local Plan. The current updated assessment takes account of representations received to the draft Local Plan and forms the evidence to support the Harrogate District Local Plan Publication Draft 2018.
- 1.5 The following information can be found within this report:
 - The policy background relating to Local Green Space allocations.
 - An explanation of the process followed by the council to identify potential Local Green Space allocations.
 - The criteria for allocating Local Green Spaces.
 - The methodology followed to assess submitted sites.

 - Information about alternative designations which may be appropriate for sites where a Local Green Space allocation is not considered suitable.

Policy Background 2

2 Policy Background

2.1 The NPPF introduces a Local Green Space designation which allows local communities to identify green areas of particular local significance for designation as Local Green Spaces.

National Planning Policy Framework

- Paragraph 76 of the NPPF states that local communities through local and neighbourhood plans should be able to identify for special protection green areas of particular importance to them. By designating land as Local Green Space local communities will be able to rule out new development other than in very special circumstances. Identifying land as Local Green Space should therefore be consistent with the local planning of an area and sustainable development and complement investment in sufficient homes, jobs and other essential services. Local Green Spaces should only be designated when a plan is prepared or reviewed, and should be capable of enduring beyond the end of the plan period.
- 2.3 At paragraph 77: the NPPF states that the Local Green Space designation will not be appropriate for most green areas or open space. The designation should only be used:
 - where the green space is in reasonably close proximity to the community it serves
 - where the green area is demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and
 - where the green area concerned is local in character and is not an extensive tract of land.
 - Where the green space will be capable of enduring beyond the end of the plan period.
- 2.4 Finally, at paragraph 78: the NPPF states that local policy for managing development within a Local Green Space should be consistent with policy for Green Belts.
- 2.5 Additional guidance relating to the designation of Local Green Space is provided within the National Planning Practice Guidance (NPPG). The following guidelines should be taken into account when designating Local Green Space:
 - There are no restrictions on the type of green space that can be designated as Local Green Space.
 - Local Green Space designations will rarely be appropriate where land has planning permission for development. Exceptions could be where the development would be compatible with the reasons for designation or where the planning permission is no longer capable of being implemented.
 - If land is already protected by Green Belt Policy or other designations such as being
 within an Area of Outstanding Natural Beauty (AONB) or a Site of Special Scientific
 Interest (SSSI) then consideration should be given to whether any additional benefit
 would be gained by designation as Local Green Space.
 - The green area will need to meet the criteria set out within Paragraph 77 of the NPPF. Whether to designate land will be a matter for local discretion.
 - The proximity of the Local Green Space to the community it serves will depend on local circumstances, including why the green area is special.
 - Blanket designation of open countryside adjacent to settlements will not be appropriate
 In particular the designation should not be proposed as a 'back door' way to try to achieve a new area of what would amount to a Green Belt by another name.
 - Land may be considered for designation if there is no public access (e.g. Where the site is valued for it's wildlife, historic significance or beauty).
 - There is no need to designate linear corridors to protect land which is already protected as a Public Right of Way (PROW).

2 Policy Background

- Local Green Spaces do not need to be within public ownership.
- Management of land designated as Local Green Space will remain the responsibility of the landowner.

Local Policy

2.6 Local Green Space can be designated within the emerging Harrogate District Local Plan or within neighbourhood plans. A draft Local Green Space Policy (NE6; Local Green Space) was consulted upon during Winter 2016. This policy and the supporting justification text has been amended in light of comments received to the Draft Local Plan Consultation. The amended policy and justification can be found at section 7 of this document and will be consulted upon within the Harrogate District Local Plan Publication Draft in early 2018. Where relevant, an appropriate policy should also be included in neighbourhood plans.

Criteria for Designation

- As highlighted above, there are no restrictions on the type of green space which can be designated as Local Green Space. Allotments or urban spaces that provide a tranquil oasis could be designated. Land which is partly developed with structures such as sports pavilions, boating lakes or war memorials could also be appropriate. The key characteristic for the designation should be the particular importance to the local community.
- The NPPG advises that land already subject to a designation could be proposed as Local Green Space, taking into consideration the benefits to be gained. Following this advice, Harrogate Borough Council does not envisage there would be a beneficial gain in identifying LGS within the following designations:
 - Special Protection Areas: protected under the EC Birds Directive (79/409/EEC).
 - Special Areas of Conservation: protected under the EC Habitats Directive (92/43/EEC), transposed into UK law by the 'Conservation of Habitats and Species Regulations 2010'.
 - Sites of Special Scientific Interest: protected under Section 28 of the Wildlife and Countryside Act 1981.
 - Local Nature Reserves: protected by the National Parks and Access to the Countryside Act 1949. These sites are owned, leased or managed by Harrogate Borough Council.
 - Registered village greens and common land: protected by the Commons Act 2006.
 - The Stray: protected by the Stray Act 1985.
- 2.9 A site proposed as Local Green Space must meet the criteria set out within the NPPF. The land must meet all the following criteria:
 - demonstrably special to the local community;
 - reasonably close proximity to the community served;
 - local in character and not an extensive tract of land; and
 - not an area with extant planning permission within which the Local Green Space could not be accommodated.
- **2.10** The land must hold particular local significance for at least one of the following reasons:
 - beauty
 - historic significance
 - recreational value
 - tranquillity
 - wildlife
 - other reason
- 2.11 Designating land as Local Green Space should:

- be consistent with local planning of sustainable development; and
- complement investment in sufficient homes, jobs and other essential services.

3 Identifying Local Green Spaces

3 Identifying Local Green Spaces

Identifying Local Green Space

As set out within section 2 of this report, the NPPF states that communities should be able to identify the green areas of particular importance to them for protection as Local Green Space. The aim of national policy and guidance is therefore to invite communities to identify green spaces, with communities being required to demonstrate how and why those spaces are special. In order to alert communities within Harrogate district to this opportunity to identify potential green spaces for protection, the following activities have taken place:

District Panel - April 2015

In order to develop an appropriate process for inviting submissions from the community, the council's Planning Policy team undertook initial consultation with the District Panel. The District Panel is made up of 850 Harrogate District residents from all backgrounds and age groups. The Panel is consulted by questionnaire (e-mail or paper) on a wide variety of topics. This aided officers by informing the development of consultation processes and the preparation of a suitable assessment methodology.

Parish Council Workshop - March 2015

- 3.3 Representatives of all parish councils across Harrogate district were invited to take part in a workshop run by the council's Planning Policy team. Representatives of residents associations and groups across the non-parished area of Harrogate town were also invited to attend the session.
- The workshop provided participants with an introduction to the Local Green Space designation, an explanation of the criteria which Local Green Spaces must meet and also a toolkit which groups could use to aid them in preparing submissions for Local Green Space. A workshop exercise provided participants with the opportunity to work in a small group with a member of the Planning Policy Team, preparing a mock submission using the tool kit provided.
- 3.5 Participants were provided with toolkits to take away from the meeting and encouraged to work within their local communities to identify potential sites and prepare submissions.

Issues and Options Consultation - Summer 2015

- 3.6 In Summer 2015, the council published its Local Plan Issues and Options document for public consultation over six weeks. The document included 74 potential Local Green Space sites which had been submitted to the council following the Parish Council Workshop. Consultees were asked to select those sites which they supported for Local Green Space designation and to provide reasons why those sites were supported.
- 3.7 Consultees were also invited to submit further sites and further supporting information for sites during the Issues and Options Consultation. LGS75 – LGS112 were all submitted during the Issues and Options consultation.

Harrogate District Local Plan - Draft 2016

During November and December 2016 the Harrogate District Local Plan Draft 2016 was consulted upon. Over 600 comments were received in relation to the Draft Local Green Space policy. The comments received have been analysed and where required, additional assessment work has been undertaken. No new sites were identified for assessment. Representations were received in relation to sites previously submitted and not designated,

however, having reviewed the representations received it was been determined that the following sites should be re-assessed to take account of the additional information submitted through the Harrogate District Local Plan Draft consultation 2016:

- 3.9 Detailed assessment forms for the above sites are included within Appendix 1 and 2 of this document. A record of the key issues raised in relation to all sites through the consultation is available within the Harrogate District Local Plan Draft Consultation Statement 2017.

Consulting Landowners

3.10 During the Issues and Options consultation, landowners were consulted by letter where contact details had been provided through the submission process. A number of representations were received from landowners through the Issues and Options consultation. A full land registry search was then undertaken for all 112 submitted sites. A letter was sent to all identifiable landowners prior to the Draft Local Plan Consultation in Autumn 2016, giving notification that their site had been submitted for consideration as Local Green Space and setting out details of whether or not the site was recommended for designation. Landowners were invited to respond to the Draft Harrogate District Local Plan consultation.

4 Assessment Methodology




Figure 4.1 Local Green Space assessment process

4.1 A methodology has been developed to provide a clear framework for assessment of submitted Local Green Spaces. This is illustrated at figure 4.1.

Local Green Space Assessment Process

- 4.2 Assessments 1 4 determine whether submitted sites are suitable for designation based on their planning status, their proximity to the community which they serve, whether they are protected under alternative designations and whether they are considered to be an extensive tract of land.
- 4.3 Sites which pass Assessments 1 4 will progress to detailed Assessment 5 to determine whether the site has been shown to be demonstrably special to a local community.
- Where one or more of the criterion within Assessment 5 are met, the site will progress to Assessment 6.
- 4.5 Sites passing assessments 1 6 will be considered for designation within the context of wider local planning objectives. The NPPF states that identifying land as Local Green Space should be consistent with the local planning of sustainable development and complement investment in sufficient homes, jobs and other essential services. The NPPG also states that Local Green Space designations should not be used in a way that undermines the aims of plan making.
- As such, the decision to allocate Local Green Space will be taken alongside decisions to allocate land for development, (e.g. for housing, employment or other commercial need), within the emerging Local Plan. The allocation of land for development will be informed by a range of studies and assessments which will make up the evidence base for the Local

Plan. The decision to designate areas for Local Green Space requires a balanced approach, considering all relevant criteria and needs within the district. This document forms part of the evidence base for the Local Plan.

Assessment 1:

Does the site have an extant planning permission for an alternative use that would be incompatible with a Local Green Space designation?

Is the site allocated within an existing Local Plan for an incompatible alternative use? Is the site likely to be allocated for an incompatible alternative use within an emerging plan?

Assessment 4: Is the site local in character and not an extensive tract of land?													
Method	Assessment												
Officer review of submission Site visit where required	The NPPF is clear that the Local Green Space designation should only be used where the site is not an extensive tract of land. Extensive tracts of land on the edge of settlements and blanket designations of open countryside will not be appropriate. Whilst there is no size limit on how small or large a Local Green Space can be, a judgement will need to be made to ensure that the proposed space is of a size that reasonably relates to the community that it serves. As such, we would expect the areas submitted to be fairly self-contained and to have clearly defined boundaries. Larger areas of the open countryside and long-distance green ways/river corridors will not generally be considered appropriate for Local Green Space designation. How does the site relate to the local area? Does the site feel part of the local area? Why? How does it connect physically, visually and socially to the area? Is the site distinct from surrounding countryside by virtue of its size, land type or landscape features? Is the site an extensive tract of land? How large is the site in comparison to the community it serves and areas of land in the vicinity? Does the site surround all or part of the village/town/local area? How has the size of the site been decided? Does the site follow natural features or existing constraints? Does the whole site justify designations or is some of the site unnecessarily included? Is the site unusually large for its use?												

Method	Assessment
Officer assessment	The proposed designation must be based on evidence to demonstrate why the green area is demonstrably special to a local community and is of particular local significance. To meet this requirement an area must fulfil one or more of the criteria below.
Officer assessment of whether the site holds particular local significance because of its beauty	This criterion relates to the visual attractiveness of a site. To meet this criterion the site must be beautiful in its own right. Sites which allow views to other areas but are not beautiful in their own right will not meet this criterion. Sites which contribute to the character of the wider area but cannot be said to be beautiful in their own right are not appropriate for designation. Is the site discernibly beautiful or more beautiful than the surrounding areas? Site visibility - Is the site visible from a public place? Are there views of the site from any key locations? Is the site (or type of landscape) specifically mentioned in any relevant landscape character assessments, conservation area appraisals or similar documents? Is the site covered by any landscape or similar designations? Does the site bring interest from further afield to the local area?
Officer assessment of whether the site holds particular local significance because of its historic significance	 In order to meet this criterion, there must be evidence to demonstrate that the site is of historic importance to the community. Are there any historic buildings, features or remains on the site? For example, listed buildings, scheduled ancient monuments, war memorials. Are there any historic landscape features on the site? For example, old hedgerows, ancient trees, historic ponds, historic garden features. Did the site play an important role in the historic development of the village or town? For example, part of the grounds for the manor house, site of an old railway station, village green. Did any important historic events take place on the site? Is there a longstanding event which takes place on the site? For example, well-dressing, maypole dancing, pace egg, plays, market.
Officer assessment whether the site holds particular local significance because of its recreational value	There must be evidence to show that the space has local significance for recreation and is of value to the community. Whilst a large number of green spaces will offer some form of recreational value, it will be necessary to identify why a particular space offers something unique that could not realistically be accommodated on other spaces that would serve the same community.

Assessment 5: Does the site hold a particular local significance?											
Method	Assessment										
	 Is there evidence or is it feasible that the site is used for playing sport? Which sport? Is this sports provision free or is club membership required? Is it good quality? Are there better facilities nearby? Is there evidence or is it feasible that the site is used for informal recreation? Can the site be accessed easily? 										
Officer assessment of whether the site holds particular local significance because of its tranquillity	There must be evidence to show that the site submitted is viewed to be of importance to the local community because of the tranquillity it provides offering a place for reflection and peaceful enjoyment. This is a subjective assessment and the council will require clear justification as to why an area is of particular value. Is the site considered to be tranquil? What features make it feel tranquil? Does it enhance the feeling of tranquillity within the local area through a feeling of remoteness? Does it provide an area of tranquillity within a busy setting by hiding man-made structures such as roads, power-lines or lighting?										
Officer assessment of whether the site holds particular local significance because of its richness of wildlife	There must be evidence to show that the site is viewed to be of local significance because of the wildlife it is home to. Is the site formally designated for its wildlife value? If the site is not formally designated, is there any evidence that there are important habitats or species found on the site? Have ecological surveys been undertaken on or close to the site? Could it form part of an ecological network? Is the site adjacent to a designated site? Has the site (or is it likely to be identified as being of local importance in the Local BAP or Local GAP? Is there any evidence, or is it likely that other wildlife of interest has been found on the site? For example, is there habitat on site which would support the presence of wildlife - are there ancient hedgerows, woodland, veteran trees on the site? Is the site the focus of local community interest and concern for its wildlife/are the community involved in steering the sites development and management? Is the site reasonably close to schools/nurseries who may visit the site? Is there any on-site interpretation of the wildlife on site? Is the site in an area generally lacking in publicly accessible natural heritage?										
Officer assessment of whether the site holds particular local significance for any other reason	There must be evidence that the proposed site holds particular local significance for the community for reasons other than those identified above. • What are the other reasons which make the site significant for the local community? Is the site a focal point or stopping place? Does it provide key views across or looking out of the local area? • What features make this site important?										

Assessment 6: Is the site demonstrably special to the local community?												
Method	Assessment											
Evidence of local support	 Submitted evidence will be reviewed to determine: How the site was identified? Was it instigated by the community or parish council? Or an individual? Was it raised at a meeting or through a survey? Has the site been subject to discussion or planning processes before? Is there a petition? Are the signatures from local people? Does the petition relate to just this one site? Is the purpose of the petition clear? Do the letters of support show that they clearly understand the justification for designating the site as a local green space? Was the site received favourably during Issues and Options Consultation? Does the evidence show that a large proportion of the community use or value the site? Have there been any objections to the designation? Who are these from and on what grounds is the objection made? Do their comments undermine or cast doubt on how special the site may be to the wider community? Is there a need for Local Green Space in this location? Is there a shortage of accessible green space in the area? Is there evidence of a need for this kid of space in particular? Could the use of the green space be replicated elsewhere in the vicinity? 											

4.7 As highlighted within the Section 2 of this report, the NPPF states that Local Green Spaces should also only be designated where they are capable of enduring beyond the Local Plan period. This highlights the importance of ensuring that if a site is designated as Local Green Space, the reasons for its designation, (i.e. its special features and qualities), will not be lost or degraded in the future. As such it is important to understand the land owners current and longer term plans for the site. All landowners were notified of their sites submission for consideration as Local Green Space and were invited to comment in the draft designations included within the Draft Local Plan. Consultation responses will help to inform the council's final considerations of whether a site is capable of enduring as Local Green Space in the future.

6 Alternative Designations

Alternatives to Local Green Space

- 6.1 Where submitted sites have not been allocated as Local Green Space, it may be appropriate to consider alternative designations to help protect or enhance the features which a local community values.
- As highlighted within the introduction to this report, a Local Green Space will only be allocated where a green space is shown to be demonstrably special and of particular significance to the local community. Not all green spaces will be suitable for this type of designation. Existing green spaces which are currently protected and are not suitable for Local Green Space designation will continue to be provided protection against development by Policy HP6, 'Protection of Existing Sport, Open Space and Recreation Facilities'. Policy HP6 provides protection against development that would involve the loss of facilities for a wide range of indoor and outdoor sport, open space and recreation facilities in public ownership or in educational use, including parks, gardens, allotments, playing fields, tennis courts, cricket grounds, bowling greens, sports halls, swimming pools, gyms, natural and semi-natural green spaces (including urban woodland), play areas, and golf courses.
- 6.3 The following designations may also be suitable:

Assets of Community Value

- Parish councils or local community groups can nominate both privately and publicly owned assets which meet the definition of community value. This is now a legal right due to the introduction of the Community Right, (sometimes called the "Community Right to Bid"). If an asset is listed and then comes up for sale, the new right could give communities a total of six months to put together a bid to buy it, (including a six-week cut-off for an initial proposal to be put forward). Agreements with land-owners

- 6.5 It may be possible for local communities to reach either formal or informal agreements with the owner of the site to ensure access to the site for local people. This may be an appropriate option where the site owner has a long-term connection with the local area, for example the owner of a large historic estate. It may be possible for the land-owner to dedicate the site as "open access land". Further information can be found as follows:

Community Purchase

- In some instances local communities have purchased important sites to ensure that they remain in community control in perpetuity. The ownership can lie with the town or parish council or with a specific trust. Examples of how communities have purchased sites can be found at:

Local Nature Reserves

6.7 A Local Nature Reserve (LNR) provides people with special opportunities to study or learn about nature or simply to enjoy it. Local Nature Reserves are designated by district or county councils and the local authority must control the LNR through ownership, lease or agreement with the owner.

Village Green status

- Anyone can apply to register land as a village green if it has been used by local people for lawful sports and pastimes "as of right", i.e without permission, force or secrecy, for at least 20 years.













The site is not formally designated for its wildlife value, although Great Crested Newts, of which there is a colony at the pond, are a protected species. The submission states that HBC's Ecologist has confirmed that the wildflower meadow is a valuable habitat for a wide variety of insects, which are a rich food source for several species of bats which visit both the pond and the meadow. 
