CONSOLIDATION ORDER 2011
(AMENDMENT NO ##) ORDER 2024

NOTICE is hereby given that North Yorkshire Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend “The Borough of Scarborough (Prohibition of Waiting and Loading and Provision of Parking) Consolidation Order 2011” by introducing the restrictions specified in the Schedule below:-

Scarborough	Woodland Avenue	North	a point 52 metres north of its junction with Woodland Rav.	a point 70 metres north of its junction with Woodland Rav.	No waiting, at any time
Scarborough	Woodland Avenue	East	its junction with Woodland Ravine	a point 75 metres north of its junction with Woodland Rav.	No waiting, at any time
Scarborough	Woodland Avenue	East	a point 14 metres south of its junction with Woodland Rise	a point 21 metres south of its junction with Woodland Rise	Disabled Parking Bay
Scarborough	Woodland Rise	South	a point 32 metres west of its junction with Woodland Ave	a point 46 metres west of its junction with Woodland Ave	Disabled Parking Bay
