**(BOROUGH OF HARROGATE (PARKING AND WAITING) (NO 13) ORDER 2024**

**NOTICE** is hereby given that The North Yorkshire Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend "North Yorkshire Council (Prohibition of Waiting and Loading and Provision of Parking) (District of Harrogate) Consolidation Order 2013" by introducing the restrictions specified in Schedule 1 below and by revoking those items in the Orders specified in Schedule 2 below:-
