If the Order is sent to the Secretary of State for the Environment for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.

This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner(s) of the land crossed by the Public Footpath described in Paragraph 1 of this Order it is expedient that the line of the Path(s) should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that The Former West Riding Of Yorkshire Area 1 (outside Dales) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Mr Karl Lenton and Ms. Helen Shepherd of Quaker Cottage, Back Lane, Askwith LS21 2JA have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Path(s) into a fit condition for use by the public.

Askwith Parish Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1. The public right of way over the land situated at Back Lane Quaker Cottage, Askwith and shown by a bold continuous black line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up from the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of paths, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority, and thereupon, The Former West Riding Of Yorkshire Area 1 (outside Dales) Definitive Map shall be modified by deleting from it that public right of way.
- 2. There shall from the date of the above-mentioned certification of this Order be the Public Footpath over the land situated at Back Lane Quaker Cottage, Askwith shown by a bold broken black line on the map contained in this Order and described in Part 2 of the Schedule to this Order and thereupon The Former West Riding of Yorkshire Area 1 (outside Dales) Definitive Map shall be modified by adding the Public Footpath to it.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.
- 4. The Former West Riding of Yorkshire Area 1 (outside Dales) Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order.
- 5. The Owner shall carry out the work described in Article 1 above, required to bring Parts 2 and 3 of the Schedule below into effect. Any new boundaries installed adjacent to any path diverted by this Order are to be a minimum of 0.5 metre from the near edge of the path(s).




