### (PROHIBITION OF DRIVING EXCEPT FOR ACCESS)

### (VARIOUS ROADS, HARROGATE)

#### **ORDER 2024**

North Yorkshire Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 3(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. Except upon the direction or with the permission of a police constable in uniform, no person shall cause or permit any vehicle to travel, except for loading, along those roads specified in Column 2 of the Schedules below:-

2.	The Council are satisfied that for the following reasons it is requisite that Section 3(1)(b) of
	the Act should not apply in relation to this Order:-

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any Order or regulations made or having effect as if made under the Act or by or under any other enactment.
- 4. This Order shall come into operation on [#] and may be cited as "The North Yorkshire Council (Prohibition of Driving) (Various Roads, Harrogate) Order 2024
