DIVERSION ORDER 2024.**

The above Order, made on 25/06/2024, under Section 119 of the Highways Act 1980 and Section 53A(2) of the Wildlife and Countryside Act 1981, will divert the Public Bridleway described below.

Public Bridleway 20.9/13 between NZ 2185 0214 and NZ 2196 0218 will be diverted onto a new route from NZ 2185 0214 to NZ 2194 0231, via NZ 2183 0222, NZ 2184 0223, NZ 2191 0223 and NZ 2191 0231.

A copy of the Order and the Order map have been placed and may be seen free of charge during normal office hours at Richmond Library, North Yorkshire until 02/08/2024. Any representations about or objections to the Order may be sent in writing to Steve Metcalfe, Definitive Map Team, North Yorkshire Council, County Hall, Northallerton, North Yorkshire DL7 8AD or email CATO@northyorks.gov.uk not later than 02/08/2024. Please state the grounds on which they are made.

Please note that objections/representations cannot be treated as confidential and may come into the public domain. Copies of any objections or representations received may be disclosed to interested parties, including the Planning Inspectorate where the case is referred to it for determination.

If no such representations or objections are duly made, or if any so made are withdrawn, The North Yorkshire Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.

This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the public it is expedient that the line of the way described in Paragraph 1 of this Order should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that The District Of Richmondshire (outside The Yorkshire Dales National Park) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Brompton On Swale Parish Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Oak Grange, Brompton On Swale and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of way, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority and thereupon The District Of Richmondshire (outside The Yorkshire Dales National Park) Definitive Map shall be modified by deleting from it that public right of way. Under no circumstances shall such certification be given before the date of confirmation of this Order.
2. There shall from the date of the above mentioned certification be the Public Bridleway over the land situated at Oak Grange, Brompton On Swale described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order and thereupon The District Of Richmondshire (outside The Yorkshire Dales National Park) Definitive Map shall be modified by adding the Public Bridleway to it.
3. The following works shall be carried out by The Authority in relation to the highway described in Part 2 of the Schedule: Provision of field gates with high level latches to BS5709:2018 at Points A and F on the attached plan. Replacement of existing bridge at Point D on the attached plan with a new bridge, design to be agreed with the Authority.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.
5. The District Of Richmondshire (outside The Yorkshire Dales National Park) Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order.

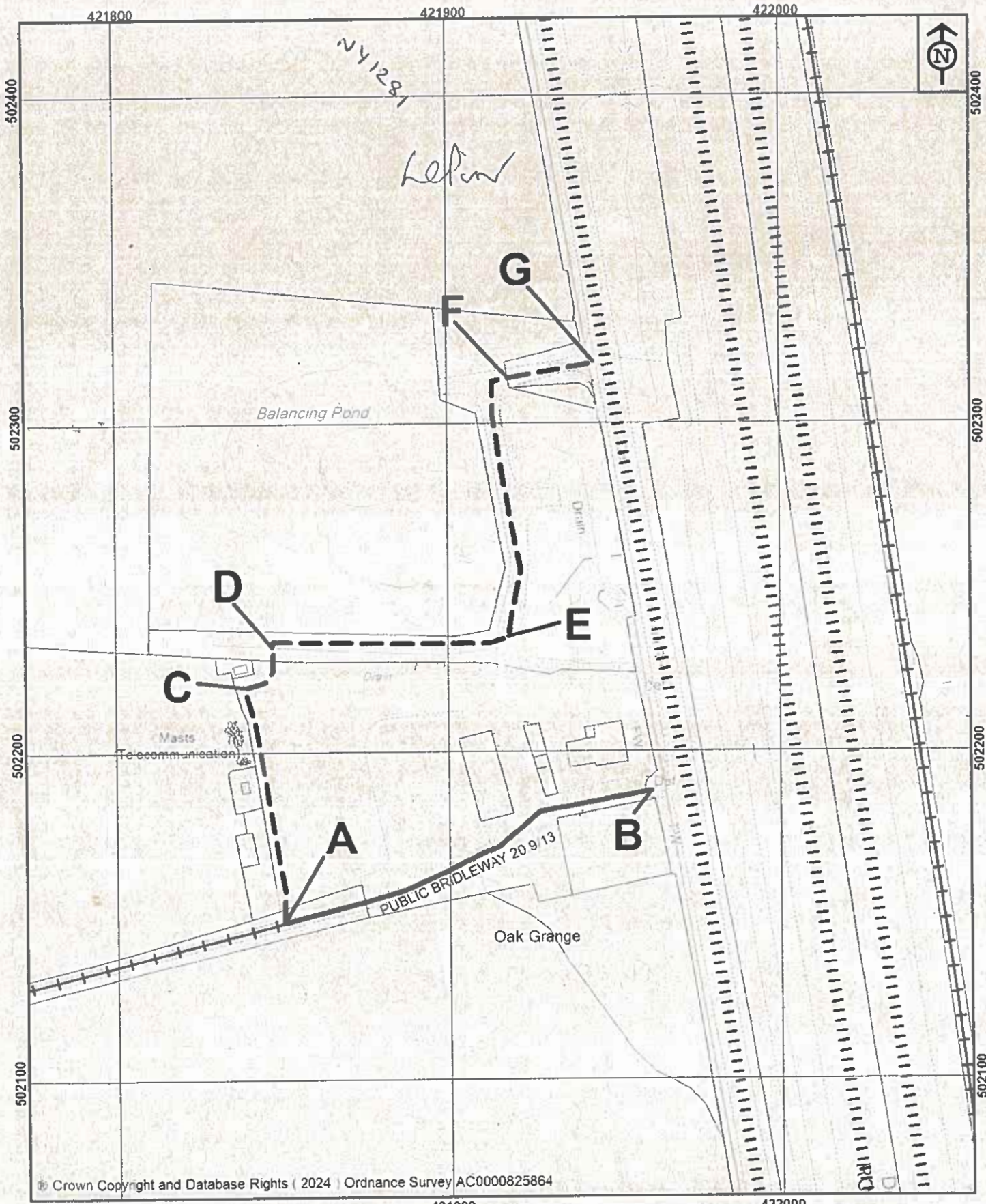
