Description of the land(s): Two adjoining fields off Skates Lane, Sutton on the Forest, York YO61 1HB and Land to the west of Stillington road, Sutton on the Forest, York YO61 1EH in the Parish of Sutton on the Forest in the District of Hambleton.

The deposit was submitted by David Hardy and was received by this authority on 23<sup>rd</sup> July 2024. 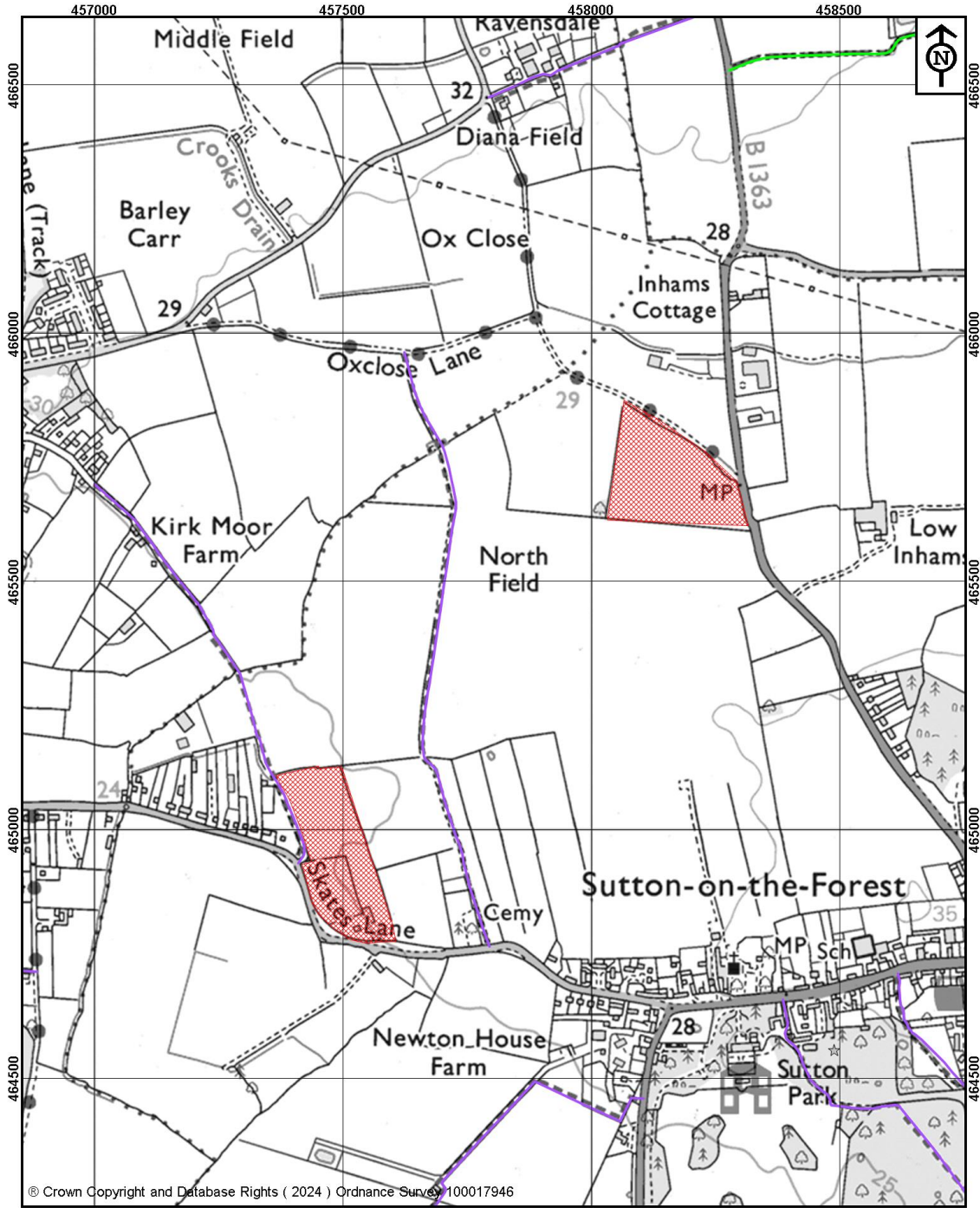
