Notice of Confirmation of a Public Path Diversion Order Highways Act 1980

The North Yorkshire Council Public Bridleway 15.44/3, Thwaite House, Fountains Earth Diversion Order 2024

The above Order made under Section 119 of the Highways Act 1980 was confirmed on 28/06/2024. The effect of the Order as confirmed is to divert the Public Bridleway as follows. Public Bridleway 15.44/3 between SE 1014 7615 and SE 1007 7604 will be diverted onto a new route from SE 1014 7615 to SE 1009 7622 and to SE 1007 7604.

A copy of the order as confirmed and the Order Map may be seen free of charge during normal office hours at Nidderdale Library, North Yorkshire until 31/10/2024. Copies of the Order and Map may be purchased from Countryside Access Services, North Yorkshire Council, County Hall, Northallerton, North Yorkshire, DL7 8AD (tel: 03001312131) at a cost of £2, or can be downloaded free from our website <https://www.northyorks.gov.uk/pathnotices>. The Order comes into force on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, described in Part 2 of the Schedule, has been completed, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 19/09/2024, make an application to the High Court. This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the public it is expedient that the line of the Public Bridleway should be diverted.

Fountains Earth Parish Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Thwaite House, Fountains Earth and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority. Under no circumstances shall such certification be given before the date of confirmation of this Order.
2. There shall from the date of the above mentioned certification be the Public Bridleway over the land situated at Thwaite House, Fountains Earth described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order.
3. The following works shall be carried out by the landowner (Mr. & Mrs. S. Halsall, Thwaite House, Lofthouse, Harrogate, HG3 5SN) in relation to the highway described in Part 2 of the Schedule: The new route must be cleared of vegetation, trees and soil accumulations etc. in order to create a firm and reasonably level surface with a usable width of at least 4 metres.

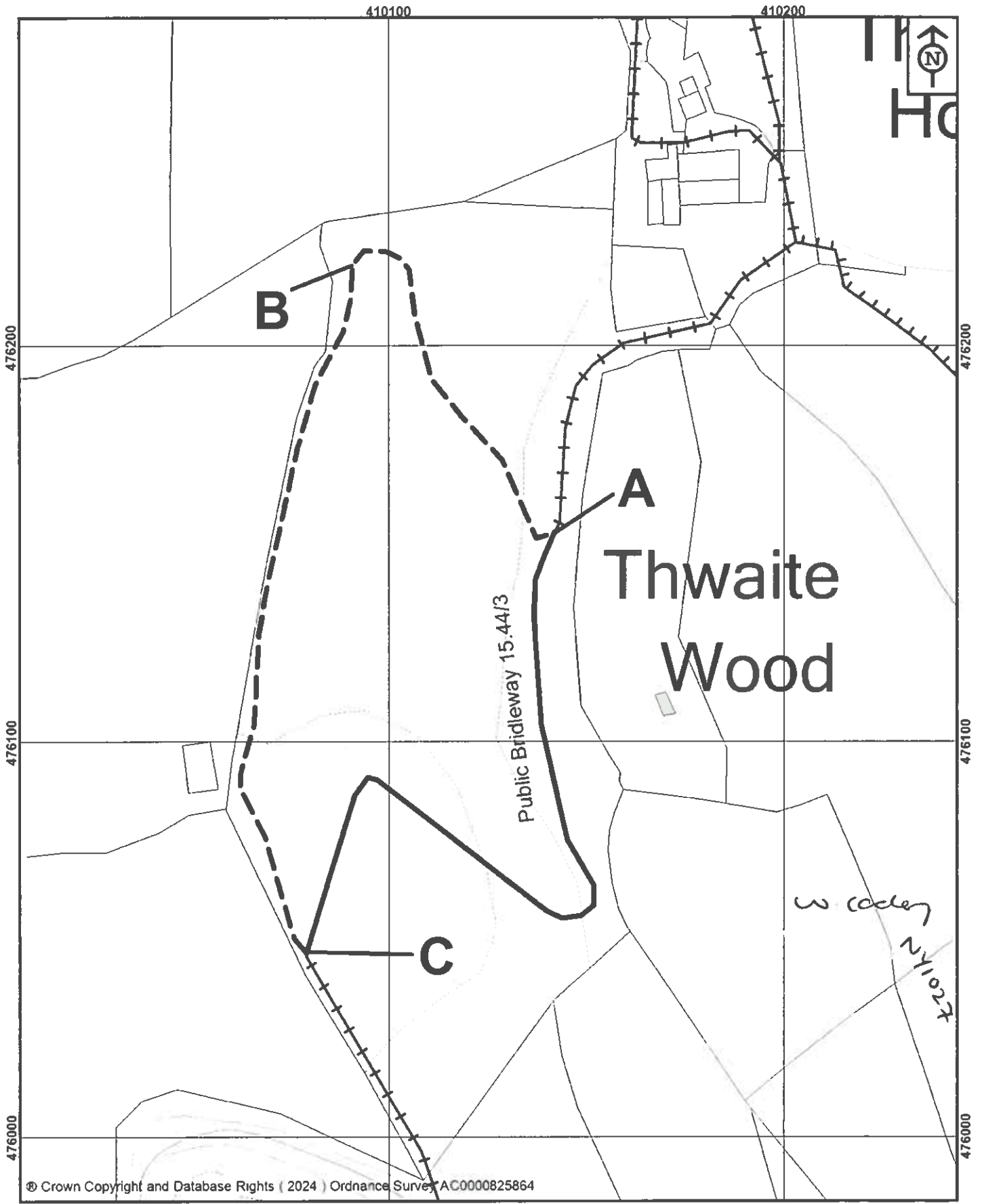
DESCRIPTION OF SITE OF EXISTING PUBLIC BRIDLEWAY

<u>Section of Public Bridleway as shown on the attached map</u>	<u>Position</u>	<u>Width</u>
Public Bridleway 15.44/3 as marked with a bold continuous line (A-C) on the attached plan.	Starts at Grid Reference 41014 47615 (Point A) and proceeds in a generally south direction along an earth track before curving round to a north west direction to descend down a steep slope, stepped in parts, and then turning to a south west direction to Grid Reference 41007 47604 (Point C). Total length is approximately 215 metres.	5ft 6in

DESCRIPTION OF SITE OF NEW PUBLIC BRIDLEWAY


<u>Section of Public Bridleway as shown on the attached map</u>	<u>Position</u>	<u>Width</u>
Public Bridleway 15.44/3 as marked with a bold dashed line (A-B-C) on the attached plan.	Starts at Grid Reference 41014 47615 (Point A) and proceeds along a woodland track in a south west direction for approximately 5 metres before turning to a north west direction, following the woodland track, for approximately 95 metres to Grid Reference 41009 47622 (Point B) and then proceeds in a generally south south west direction along a boundary wall for approximately 181 metres to Grid Reference 41007 47604 (Point C).	4 metres
