PLEASE NOTE: This deposit may affect rights over the land described below. Deposits made under section 31(6) of the Highways Act 1980 may prevent deemed dedication of public rights of way over such land under section 31(1) of that Act.

Description of the lands: Land located within Gilling with Hartforth and Sedbury in the Parishes of Gilling with Hartforth and Sedbury and Middleton Tyas in the District of Richmond.

The deposit was submitted by Laura Aikman of GSC Grays on behalf of William George Baker Baker and The Trustees of The William Baker Baker's 1990 Settlement and was received by this authority on 23rd July 2024. 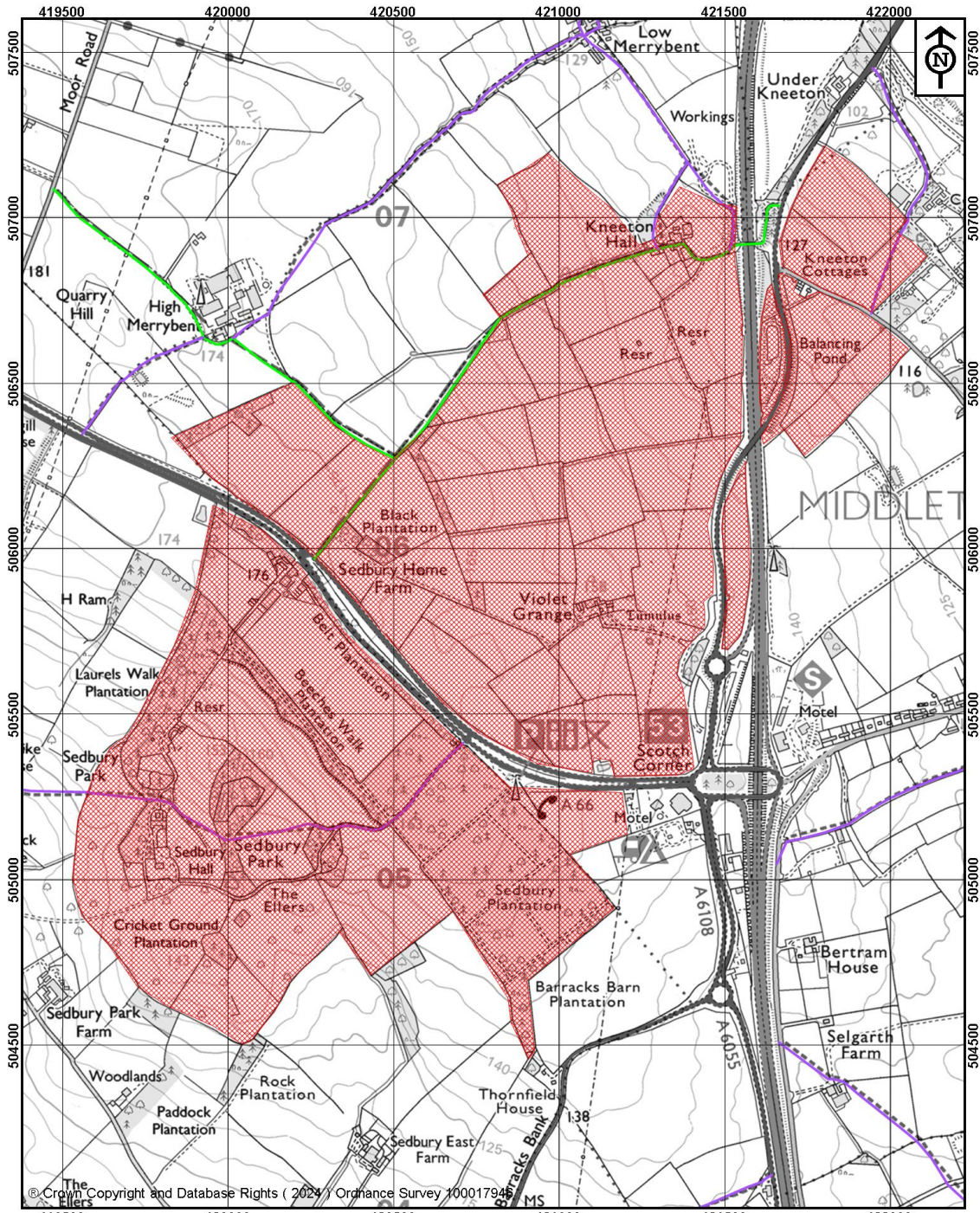
