**SUTTON-IN-CRAVEN DIVERSION ORDER 2024**


This order is made by The North Yorkshire Council under Section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely:

Planning Permission granted by The North Yorkshire Council on 1 December 2023 for the construction of six dwellings under reference ZA23/25033/FUL. The Diversion is to allow for the Planning Permission to be implemented.

**BY THIS ORDER:**

1. The footpaths over the land shown by a bold black continuous line on the attached Plan and described in Part 1 of the Schedule to this order ("the Schedule") shall be diverted as provided below.
2. There shall be created to the reasonable satisfaction of The North Yorkshire Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashed line on the attached plan.
3. The diversion of the footpaths shall have effect on the date on which The North Yorkshire Council certify the terms of Article 2 above have been complied with.
4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule: The materials used in the surface shall be tarmac and the highway will have an approximate width of 2m.
5. Chris Swarbrick of Sandacre Limited 3 The Acres, Sutton in Craven, Keighley, North Yorkshire BD20 7AT is required to pay for the cost of carrying out the said works.
6. Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

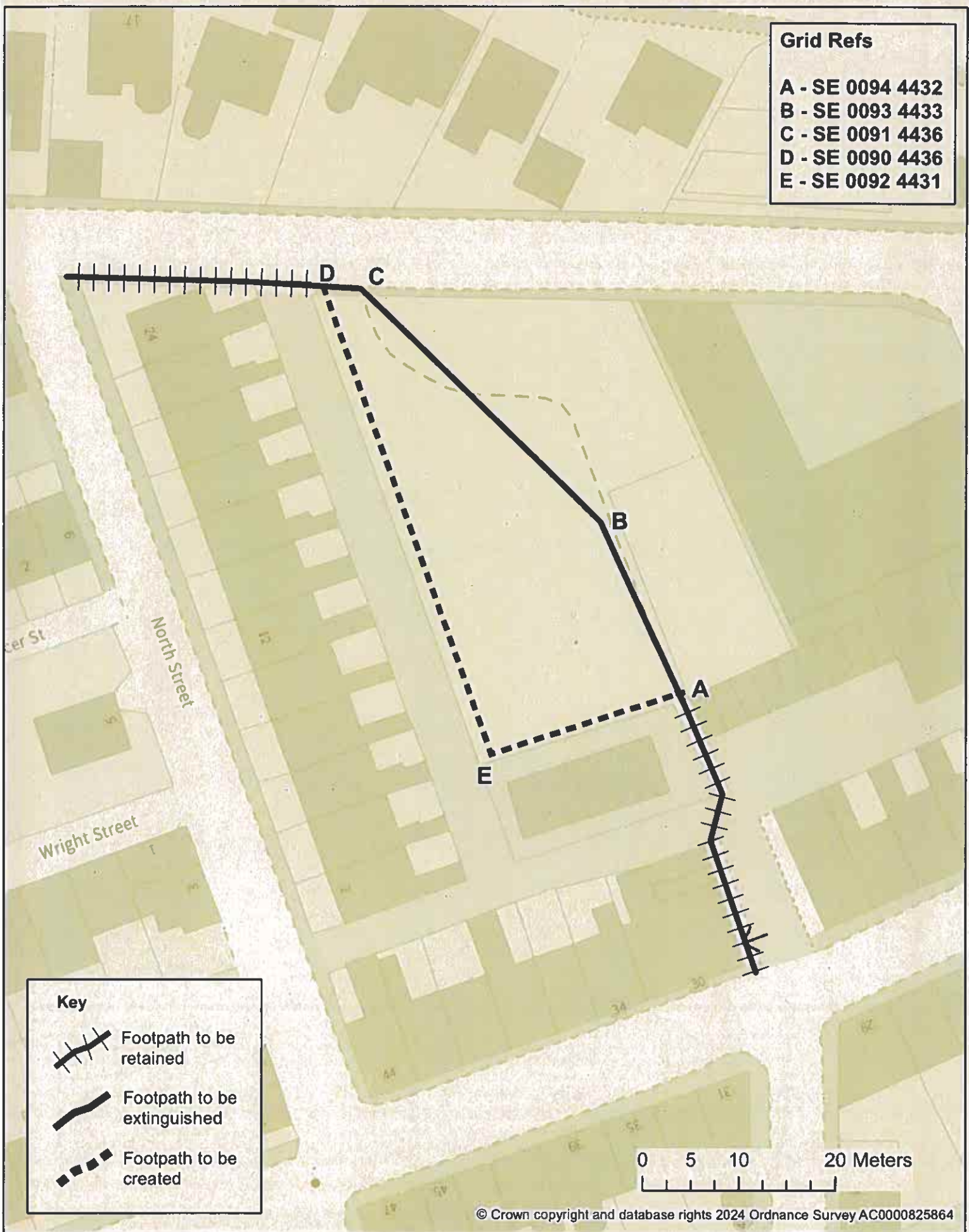
