**BOROUGH OF HARROGATE (PARKING AND WAITING) (NO 13) ORDER 2024**

**NOTICE** is hereby given that on 25 October 2024 The North Yorkshire Council made an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which is to amend “North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (District of Harrogate) Consolidation Order 2013” by introducing the restrictions specified in the table below:-

**WAITING PROHIBITED AT ALL TIMES WITH EXEMPTIONS**

1	Ure Bank Top (U3001), Ripon	West	From a point on the west side of Ure Bank Top from its intersection point with the projected boundary line of Nos.1/ 3 Ure Bank Top for a distance of 6.6 metres in a southerly direction. (No.1 Ure Bank Top)
2	Crescent Parade (U3011), Ripon	North East	From a point 44.5 metres north west of the intersection between Crescent Parade and North Street, in a north westerly direction for 6.6 metres.
