THE NORTH YORKSHIRE COUNCIL (PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING) CONSOLIDATION ORDER 2011 (AMENDMENT NO 110) ORDER 2024

The North Yorkshire Council in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1) and 45 to 49 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

- This Order shall come into operation on **15 November 2024** and shall be cited as "The North Yorkshire Council (Prohibition of Waiting and Loading and Provision of Parking) Consolidation Order 2011 (Amendment No 110 Order 2024".
- This Order hereby amends the Order specified in Schedule 1 to this Order, insofar as it relates to the lengths of road specified in Schedule 2 to this Order.
- The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4 (1) In this Order the following expressions have the meanings hereby respectively assigned.
 - "1984 Act" means the Road Traffic Regulation Act 1984.
 - "2004 Act" means the Traffic Management Act 2004.
 - "2000 Regulations" means The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.
 - "Ambulance" means a vehicle which-
 - (a) is constructed or adapted for, and used for no other purpose than, the carriage of sick, injured or disabled people to or from welfare centres or places where medical or dental treatment is given; and
 - (b) is readily identifiable as a vehicle used for the carriage of such people by being marked 'Ambulance' on both sides.
 - "Bus" means a vehicle which is constructed or adapted to carry more than eight seated passengers in addition to the driver.
 - "Cause" includes permitting;
 - "Charging Hours" means such hours and on such days as are specified in The Schedule to this Order.
 - "Civil enforcement officer" means any officer of the Council who is authorised to supervise and control vehicles in the parking place and enforce the provisions of this Order pursuant to Section 76 of the 2004 Act and Section 63A of the 1984 Act.
 - "Coach" means a passenger vehicle constructed or adapted to carry more than 16 seated passengers with a maximum gross weight exceeding 7.5 tonnes and with a maximum speed exceeding 60 mph.
 - "Controlled hours" means those hours and on those days during which there are limitations on parking, waiting, loading and unloading.
 - "Disabled person's badge" means a badge in the form prescribed by Regulation 11 of the 2000 Regulations issued by a local authority for display on a motor vehicle driven by a disabled person, or used for the carriage of a disabled parson and includes a replacement badge issued in accordance with Regulation 7 of the 2000 Regulations.

- "Enactment" means any enactment whether public general or local, and includes any order, bye law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;
- "Goods" includes goods or burden of any description.
- "Goods vehicle" means a motor vehicle constructed or adapted for use for the carriage of goods and exceeds 3050 kilograms or 3500 kilograms if the vehicle carries a container or containers for holding for the purpose of its propulsion any fuel that is wholly gaseous at 17.5 degrees Celsius under a pressure of 1.013 bar or plant and materials for producing such fuel.
- "Motor car" means a mechanically propelled vehicle constructed solely for the carriage of passengers and their effects, is adapted to carry not more than seven passengers exclusive of the driver and does not exceed 3050 kilograms or alternatively does not exceed 2540 kilograms and is not a goods vehicle
- "Motorcycle" means a mechanically propelled vehicle with less than 4 wheels and an unladen weight not exceeding 410 kilograms. As defined in the Road Vehicles (Construction and Use) Regulations 1986.
- **"Motor Vehicle"** has the meaning assigned to it by Section 136 of the Road Traffic Regulation Act 1984.
- "Owner" in relation to a vehicle means the person who is the registered keeper of the vehicle and in relation to a vehicle, which is subject of a hiring agreement, or hire purchase agreement means the person in possession of that vehicle under that agreement.
- "Parking Disc" means a disc issued by the Council capable of showing the quarter hour period during which a period of waiting begins.
- "Parking Place" means an area on a highway described or designated as a parking place in The Schedule to this Order.
- "Parking Space" means a space in a parking place that is provided for the leaving of vehicles.
- "Parking Ticket" means a ticket issued by a pay and display machine on payment of the appropriate fee.
- "Permit" means a permit issued by the Council in accordance with their rules.
- "Relevant position" means exhibited on the dashboard or fascia of the vehicle, or, where the vehicle is not fitted with a dashboard or fascia, exhibited in a conspicuous position on the vehicle, so that the front is clearly legible from the outside of the vehicle.
- "Road" means any length of highway or of any other road to which the public has access, and includes any bridge over which a road passes.
- "Slipway" means a narrow sloping area of road which grants access to the sea for vessels and vehicles associated with the launching or retrieval of the vessels.
- "Specified Days" means Bank Holidays, Saturdays and Sundays from and including Good Friday until and including Spring Bank Holiday Monday and all days from and including the Tuesday following Spring Bank Holiday Monday until and including the 30th September in each year.
- "Taxi" means a vehicle licensed by the Council to ply for hire and does not include private hire vehicles.

"Taxi rank" means an area of carriageway reserved for use by taxis plying for hire.

"Timing point" means a place where a public service vehicle may wait for the purpose of synchronising its journey time with the published schedule.

"Trailer" has the meaning assigned to it by Section 136 of the Road Traffic Regulation Act 1984.

"Zone" refers to any one of the parking zones containing the roads or lengths of roads described in the Schedule.

- (2) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to the Article or Schedule bearing that number in this Order.
- (3) Any reference in this Order to an enactment shall be construed as a reference to that enactment as amended, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- Nothing in this Order shall render it unlawful to cause any vehicle to wait during the controlled hours for the lengths of road, on the side of road referred to therein, or in any part of a parking place, if the use of that part has not been suspended, for a period no longer than is necessary for:
 - (a) a person to board or alight from the vehicle or load thereon or unload therefrom his or her personal luggage;
 - (b) goods to be loaded on or unloaded from a vehicle, where the vehicle is necessary for the collection or delivery of those goods, (except in those roads or lengths of roads and during those hours where loading and unloading is prohibited).
 - (c) a vehicle directly used in connection with any of the following operations, namely:
 - (i) the removal of any obstruction to traffic;
 - (ii) the maintenance, improvement or reconstruction of any of the said lengths of road or sides of road; or
 - (iii) the laying, erection, alteration or repair in, or in land adjacent to any of the said lengths or sides of road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any electronic communications network or electronic communications service as defined in Schedule 3A and Section 32 of the Communications Act 2003;
 - (d) a vehicle, not being a passenger vehicle, being used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;
 - (e) a vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 125(1) of the Postal Services Act 2000;
 - (f) a vehicle to wait at or near to any premises situated on or adjacent to said side or any of the said lengths of road or parking place for so long as such waiting by that vehicle is reasonably necessary in connection with a funeral; or

- (g) a vehicle is being used for fire brigade, ambulance or police purposes:
- (h) a vehicle displaying a valid dispensation.
- (2) Nothing in this Order shall render it unlawful to cause any taxi, to wait upon a taxi rank while plying for hire.
- (3) Nothing in this Order shall render it unlawful to cause a vehicle, to wait in accordance with the provisions contained in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 (SI 2000 No. 683) and any amendments thereto.
- (4) Nothing in this Order will make it illegal for a driver of a public service vehicle to allow that vehicle to wait at a recognised timing point.
- Every vehicle left in a parking place in accordance with the provisions of this Order shall stand so that its wheels are within the parking place and it does not obstruct the premises adjacent to the side of the road on which the vehicle is standing.
- During the period of operation of a parking place specified in this Order no person shall without the written consent of the Council and subject to such conditions as the Council from time to time decide use any vehicle while it is in the parking place, in connection with any commercial activities, or the advertisement or sale of any article to persons in or near the parking place, or in connection with the selling or offering for hire of his skill or services.
- No person shall use any part of a parking place or any vehicle parked in a parking place
 - (a) for sleeping or camping or cooking; or
 - (b) for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place.
- 9 (1) Any person duly authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of:
 - (c) facilitating the movement of traffic;
 - (d) promoting its safety;
 - (e) preventing obstruction;
 - (f) the undertaking of works in or adjacent to the parking place; or
 - (g) for the convenience of occupiers of premises adjacent to the parking place.
 - (2) When the parking place or any part thereof, has its operation suspended pursuant to paragraph (1) of this Article no person shall cause any vehicle to wait or load or unload in that parking place or part thereof for the duration of the suspension, provided that nothing in this paragraph shall render it unlawful to cause an ambulance or any vehicle being used for fire brigade or police purposes, to enter or be left in that parking place or part thereof during the period of suspension, or to any other vehicle so left, if that vehicle is displaying a valid dispensation issued by the Council.
- 10. Where a Civil enforcement officer is of the opinion that any of the provisions of this Order have been contravened or not complied with in respect of a vehicle he may remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.

- 11. Where a Civil enforcement officer is of the opinion that any of the provisions of this Order have been contravened or not complied with in respect of a vehicle he may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.
- 12. A Police Constable in uniform or Civil enforcement officer may move or cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in a parking place.
- 13. Where a Civil enforcement officer is of the opinion that any of the provisions of this Order have been contravened or not complied with in respect of a vehicle he may wish to immobilise or cause to be immobilised the vehicle by fixing a device for this purpose to the wheel of the vehicle.

Prohibition on Waiting, Loading and Unloading

14. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a Civil enforcement officer cause any vehicle to wait nor allow goods to be loaded on or unloaded from the vehicle at the times and in the lengths of road so specified in Schedule 2 to this Order.

Parking for Payment

- 15. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a Civil enforcement officer, cause any vehicle, other than an authorised vehicle, to wait in any parking place in the lengths of road, and for the times so specified, in Schedule 2 to this Order, and which are thereby designated as parking places, unless it is displaying in the relevant position a parking ticket valid for that parking place at that time or a permit valid for that parking place at that time.
- 16. No vehicle which has been taken away from in a parking place, after the parking time purchased has expired, shall until the expiration of 1 hour from the time it was taken away again be left in that parking place during the charging hours.
- 17. The amount of charge for a vehicle left in a parking place during the charging hours shall be as detailed in Schedule 3 to this Order.

Parking without Payment

18. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a Civil enforcement officer, cause any vehicle, other than an authorised vehicle, to wait in any of the lengths of road, and for the times specified, in Schedule 2 to this Order, and which are thereby authorised for use as parking places, nor may a vehicle return to any such parking space in the same parking place until the expiry of the time specified for that parking place in the Schedule unless it is displaying a permit valid for that parking place at that time. The types of permit, parking places, entitlement and permit charges are described in Schedule 4 to this Order.

Disc Parking

19. A vehicle that is parked in a parking place in the lengths of road specified in the Schedules to this Order as being in a Disc Zone and does not display a permit valid for that zone must display a parking disc, at all times, in the relevant position, at all times and set the disc so that it indicates the quarter of an hour period during which the vehicle arrived at the parking place. The types of permit, parking places, entitlement and permit charges are described in Schedule 4 to this Order.

Motorcycle Parking

20. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a Civil enforcement officer, cause any vehicle, other than a solo motorcycle, to wait in any of the lengths of road, and for the times specified, in Schedule 2 to this Order, and which are thereby authorised for use as parking places,

nor may a vehicle return to any such parking space in the same parking place until the expiry of the time specified for that parking place in Schedule 2 of this Order.

Permit Parking

21. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a Civil enforcement officer, cause any vehicle to wait in any parking place during the times specified for that parking place, in Schedule 2 to this Order unless it is displaying in the relevant position a permit valid for that parking place at that time, or being a Disc Parking Place, is displaying a parking disc as specified in Article 19. The types of permit, parking places, entitlement and permit charges are described in Schedule 4 to this Order.

Disabled Parking

22. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a Civil enforcement officer cause any vehicle to wait in any disabled parking place described in Schedule 2 to this Order unless it is displaying a Disabled Person's Badge and disc (parking clock) in the relevant position and set the disc so that it indicates the quarter of an hour period during which the vehicle arrived at the parking place in the relevant position.

Loading Bays

23. Save as provided in Article 5 no person shall except upon the direction or with the permission of a Civil enforcement officer cause any vehicle, unless specified in Schedule 2, to wait other than to allow loading or unloading from the vehicle, in accordance with the particulars of Schedule 2 in the lengths of road so specified in Schedule 2 to this Order.

School Entrances

24. No person shall except upon the direction of a Civil enforcement officer cause any vehicle to stop or remain at rest on any of the sides of lengths of road, so specified in Schedule 2 to this Order between the hours and on the days specified therein except as may be necessary to avoid an accident or is prevented from proceeding by circumstances outside his control.

Penalty Charge and Payment

25. Where a Motor Vehicle parks in contravention of the provisions of Sections 19 or 21 of the Road Traffic Act 1988 (prohibition of parking of HGVs on Verges, central reservations and footways and driving or parking on Cycle Tracks), a penalty charge shall be payable by the owner for each day of the said contravention or noncompliance. 
