

**THE NORTH YORKSHIRE COUNCIL**  
**(HARROGATE, KNARESBOROUGH, PANNAL AND BURN BRIDGE) (PARKING AND WAITING) (NO 48) ORDER 2025**

**NOTICE** is hereby given that on 20 December 2024 The North Yorkshire Council made an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which is to amend “North Yorkshire County Council (Parking and Waiting) (No 16) Order 2013” and the “North Yorkshire County Council (Parking and Waiting) (No 35) Order 2013” by introducing the restrictions specified in the table below:-
