The effect of the confirmed Order is to modify the Definitive Map by adding a Footpath from Skipton Road running south eastwards between no 126 Main Street and no 2 Skipton Road then north-north eastwards to Gordon Terrace. .

If any person aggrieved by the confirmed Order wishes to question its validity on the ground that it is not within the power of Section 53 of the above-named Act, or that any requirement of Schedule 15 of the Act has not been complied with in relation to the Order, he or she may, within 42 days of the date of this Notice, make an application to the High Court under Schedule 15(12) to the Act.

This Order is made by The North Yorkshire Council under Section 53(2) (b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the District of Craven (outside the Yorkshire Dales National Park) Definitive Map and Statement requires modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i). This is due to the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The North Yorkshire Council hereby order that -

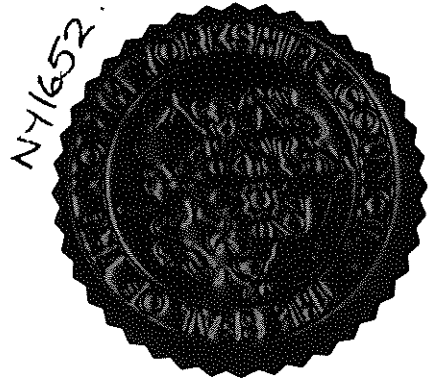
1. For the purpose of this Order the relevant date is 21<sup>st</sup> August 2024.
2. The District of Craven (Outside the Yorkshire Dales National Park) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Footpath 05.13/35 Gordon Terrace to Skipton Road, Cononley Modification Order 2024".

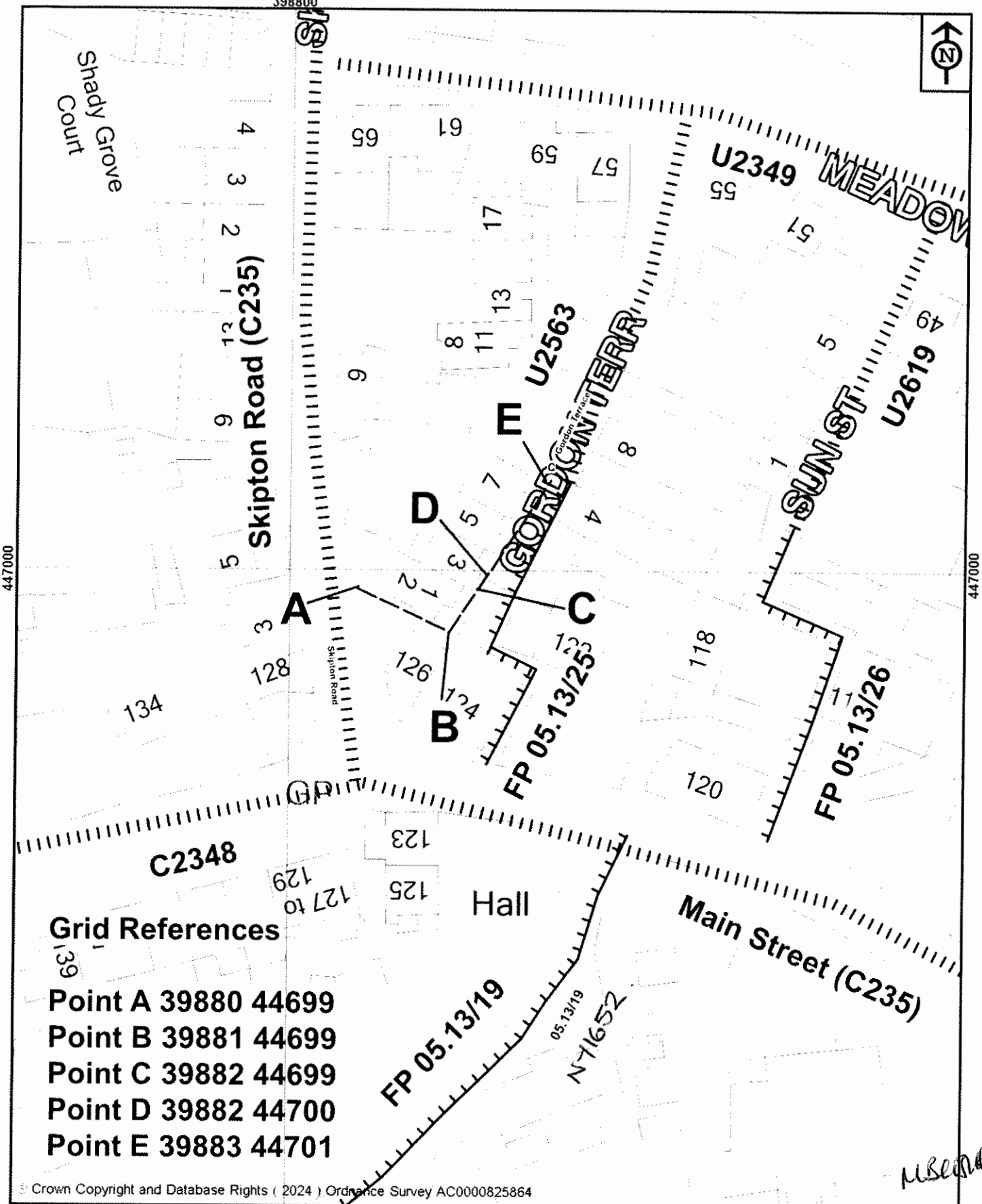
