The Authority gives notice that it has made an Order on 10 January 2025 under Section 257 of the Town & Country Planning Act 1990 because it is satisfied that it is necessary to divert the public footpath described below to enable development described in the Schedule to be carried out in accordance with the planning permission granted under reference ZA23/25041/HH.

Footpath No.05.26/47 running generally in a south-southeasterly and then south-easterly direction from Grid Reference SD7166 7146 through the curtilage of Myresfield Bungalow to Grid Reference SD7176 7130 of 1.2 metres width, will be diverted onto a new route from Grid Reference SD7166 7146 in a south easterly direction to a pedestrian gate in the wall northeast of the curtilage of Myresfield Bungalow at Grid Reference SD7178 7133, and on to its junction with Lowkber Lane at Grid Reference 7178 7133. The new route will be 2 metres wide throughout on a grass surface. The route will cross a culvert in the highway verge between the new gate and the carriageway surface.

If the Order is sent to the Secretary of State for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.
