**(NO 14) ORDER 2025**

**NOTICE** is hereby given that on 17 January 2025 made an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to revoke those Orders as set out in Schedule 2 below by introducing the restrictions specified in Schedule 1 below:-

**WAITING PROHIBITED AT ANY TIME EXCEPT FOR DISABLED BADGE HOLDERS**
