The tap plates will be sel standing with weighted bases and will be finished in a soft red material. This will hel visually impaired people differentiate them from our building. Cafe barriers will be in increments or 2m each attaching to a freestanding post creating 6m coverage there will be one at 1.5m covering the end return. Parasols will be fabric with advertising of products we stock and sell only.
