### **Notice of Confirmation of a Public Path Diversion Order Highways Act 1980**

#### **The North Yorkshire Council Public Footpath No. 25.94/11, The Pheantry,**

**Terrington. Diversion Order 2024** The above Order made under Section 119 of the Highways Act 1980 was confirmed on 28.2.2025. The effect of the Order as confirmed is to divert the Public Footpath as follows: Public Footpath No. 25.94/11 from GR SE6732 7058 to GR SE6730 7057, will be diverted onto a new route from GR SE6732 7058 to GR SE6730 7055. Also, from GR SE6730 7057 to GR SE6732 7050, will be diverted onto a new route from GR SE6730 7057 to GR SE6732 7050.

A copy of the order as confirmed and the Order Map may be seen free of charge during normal office hours at Malton Library, St Michael St, Malton, North Yorkshire until 7.5.2025. The Order comes into force on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new sections of path, described in Part 2 of the Schedule, have been completed, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 26.3.2025, make an application to the High Court. **DIVERSION ORDER 2024**

This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the Public Footpath described in Paragraph 1 of this Order, it is expedient that the line of the Public Footpath should be diverted.

Mr T Watson, The Pheasantry, Terrington, York, YO60 6PU has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Path into a fit condition for use by the public.

Terrington Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

**BY THIS ORDER:**

1. The public right of way over the land situated at The Pheasantry, Terrington and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new sections of path, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority. Under no circumstances shall such certification be given before the date of confirmation of this Order.
2. There shall from the date of the above mentioned certification be the Public Footpath over the land situated at The Pheasantry, Terrington described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order.
3. The following works shall be carried out by the applicant in relation to the highway described in Part 2 of the Schedule: provide a gap at Point D, and install pedestrian gates, at Points F and H, all to BS5709:2018, and cap the well between Points B and H. Also, install timber fencing from Points D - E - F and Point B - H, alongside the new paths, leaving a minimum gap of 2.5 metres.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

From Grid Reference 46732 47058 (Point A) in the curtilage of The Pheasantry and curving east for approximately 3 metres to a gap at Grid Reference 46733 47058 (Point D) and then running east for approximately 17 metres along the boundary wall to Grid Reference 46734 47058 (Point E), and then running south along the boundary fence for approximately 27 metres to a pedestrian gate into a field at Grid Reference 46734 47055 (Point F), and then running west south west, along the boundary fence for 45 metres to Grid Reference 46730 47055 (Point G), near to the corner of the field. Total distance of approximately 92 metres on a grass surface.	Points A-D-E-F 2.5 metres  Points F-G 2 metres

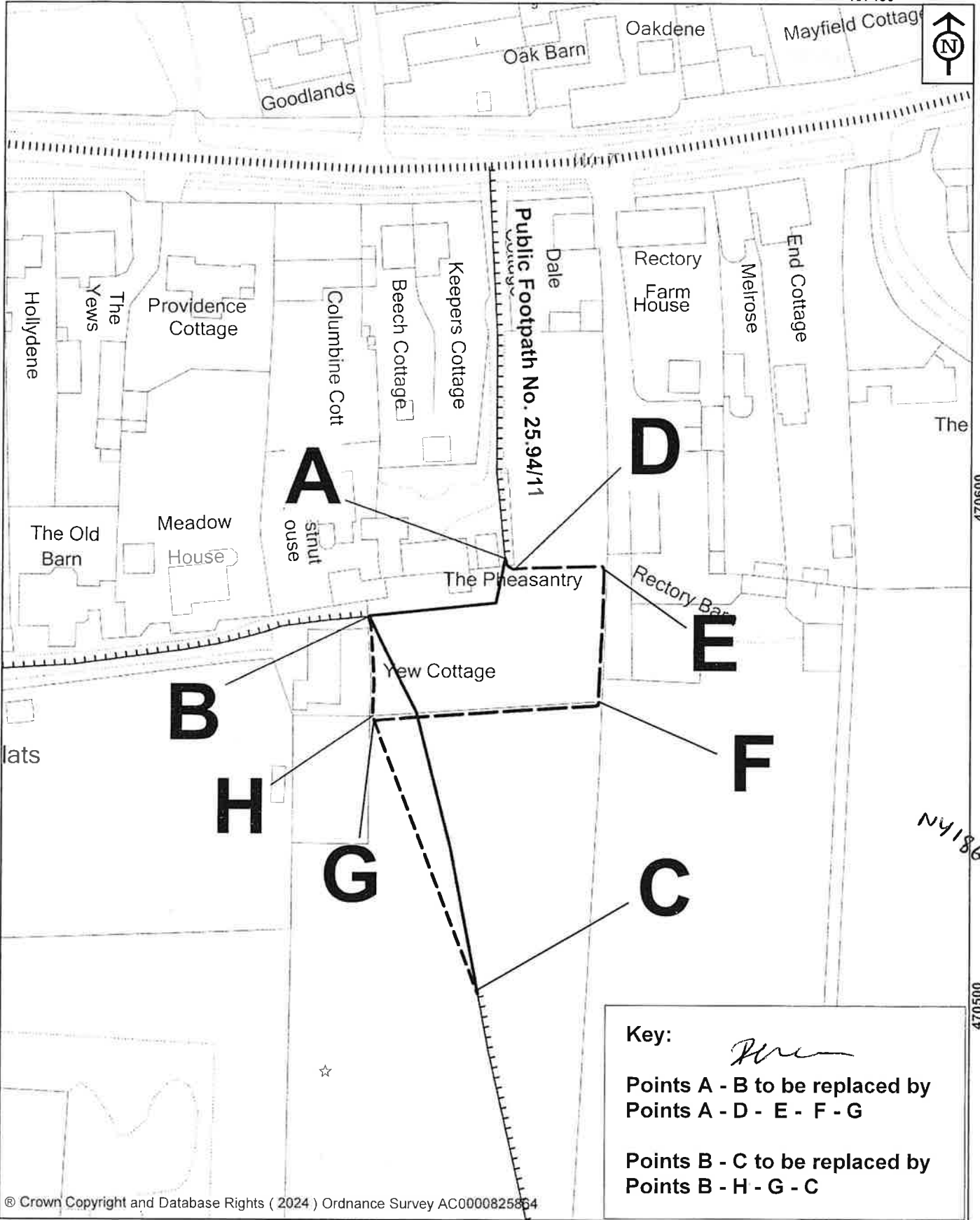
