Notice of Confirmation of a Public Path Creation Order Highways Act 1980
The North Yorkshire Council Public Bridleway No 15.43/14 Crimple Viaduct, Follifoot
Creation Order 2023 The above Order made under Section 26 of the Highways Act 1980 was confirmed on 10 February 2025. The effect of the Order as confirmed is to create the Public Bridleway as follows. Commences at the northern end of Bridleway No 15.43/16 at Grid Reference 43212 45289, then runs in a north-westerly direction for approximately 10 metres, to its junction with the eastern end of Bridleway No 15.54/61 at the Harrogate Borough parish boundary Grid Reference 43211 45289.

A copy of the order as confirmed and the Order Map may be seen free of charge during normal office hours at Harrogate Library, North Yorkshire until 17 April 2025. Copies of the Order and Map may be purchased from Countryside Access Services, North Yorkshire Council, County Hall, Northallerton, North Yorkshire, DL7 8AD (tel: 03001312131) at a cost of £2, or can be downloaded free from our website www.northyorks.gov.uk/pathnotices. The Order comes into force 6 March 2025, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 06/03/2025, make an application to the High Court.

This Order is made by North Yorkshire County Council (“the Authority”) under Section 26 of the Highways Act 1980 (“the 1980 Act”) because it appears to the Authority that, having regard to the matters set out in Section 26(1) there is a need for the public Bridleway over the land to which this Order relates and that it is expedient that the path should be created.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Former West Riding of Yorkshire (Area2) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, the creation (as authorised by this Order) of a new right of way over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a Public bridleway.

Harrogate District and Harrogate Town Councils have been consulted as required by Section 26(3) of the 1980 Act.

BY THIS ORDER

1. There shall from the date of confirmation of this Order be a public Bridleway over the land at Crimple Viaduct described in Part 1 of the Schedule to this Order and shown by bold broken line on the map attached to this Order, and thereupon the Former West Riding of Yorkshire (Area2) Definitive Map shall be modified by adding that way to it, and the definitive statement shall be modified as described in Part 3 of the schedule to this order.
2. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.

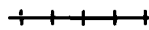
