Chapter 3 Key Issues. Paragraph 3.38. Question 10.

"At this early stage in the process WE ARE NOT CONSULTING ON ANY PROPOSED SITE ALLOCATIONS FOR THE SETTLEMENTS but are focusing instead on HOW we will choose the best sites to deliver the strategy."

Despite Selby District Council training for Hemingbrough Parish Councillors at the Eastern Community Engagement Forum and at two further sessions, this 'Plan Selby' Consultation has already been used as a device by the Parish Council to decide its preferred "Plan Selby" SITE ALLOCATIONS for residential development, namely Plots 1, 7 & 8 as identified and numbered in your consultation document.

The collective decision was made at an early meeting of the Parish Council on Thursday 15 January 2015 at the end of their Agenda Item 1 "Plan Selby" when no Councillor declarations of interest had been asked for or made. Implicit in the Parish Council's collective decision is their 'Plan Selby' commitment for an estate of houses on three adjacent plots thereby disqualifying owners of other land from their consideration. Presumably the Parish Council actions affect the value of the three named plots, neighbouring plots and those plots elsewhere in the village that Councillors did not support.

The Chairman justified the Council's collective decision on the grounds Councillors had been elected to make decisions on behalf of residents. Four Councillors vehemently objected to making such a decision without consultation with residents and so a plan was hatched to hold a public meeting in February 2015 to gain acceptance for what they had already decided from the expected low number of residents likely to attend. These events were captured by video recording of the Parish Council under rules allowing meetings to be recorded by the public.

Parish Council elections take place in May 2015 so perhaps this was an attempt for the dominant clique to force a Council decision before their seats are contested.

Hemingbrough Parish Council has refused to support a Village/Parish Plan for many years and has virtually no idea of the wishes of residents other than comments sought by a small, volunteer, Community Group about three year ago.

Clearly the answer to your questions "Paragraph 5.75 Q51 a) How should Hemingbrough grow and develop? b) What else is needed in Hemingbrough that could be allocated a site?" is the Parish Council elected representatives must survey the residents to find out 'How should Hemingbrough grow' and attempt to form a consensus instead of allowing a few people to contribute their views or make far-reaching decisions for a Strategic Plan.

Section 5.58. The area between Brayton and Selby Urban Area is designated as a Strategic Countryside Gap, the boundaries of which may be reviewed.

Question 43. a) How should Brayton grow and develop?

Throughout the Consultation emphasis has been put on "Nothing is set in stone" except a question about the 'Brayton Strategic Gap' was said to be "set in semi-stone" by a Councillor at the Eastern Community Engagement Forum. Even the Consultation narrative "the boundaries of which MAY be reviewed" suggest this is a special topic that has not received the same attention as the rest of the District.

A village only 1.5 miles from Selby Town, a six minute journey by car that now "incorporates a substantial part of suburban Selby" and is a "suburban commuter settlement serving Selby, Leeds, York and Doncaster" that has "few immediate barriers to growth in any direction" and has excellent bus services and other facilities should be given equal consideration.

I believe the 'Strategic Gap' which was set up in the last century, and which is described as "several agricultural fields" in the Village Plan, should be reconsidered as part of 'Plan Selby' as an excellent place for residential housing close to the Town and amenities.
