As I find the document confusing I wish to make the following comments.

Cawood is an unspoilt rural village where the main local employment is agriculture or agriculture related. Villagers travel to Selby or York to shop and mainly Selby, York or Leeds to work.

Most of the properties in the village are old with just a few small developments which have been built over the past 30 years.

Cawood is also an historical village and the appeal of the village is its historical nature. There is the remains of Cawood Castle which is under the control of the Landmark Trust and the Castle Garth field (gardens) which is a 14 acre field owned by the Parish Council but under the control of English Heritage. This field is protected due to the existence of the greater crested newt.

If any building takes place an archaeological survey needs to take place.

In the past the village flooded on regular occasions however due to the construction of the flood wall in 1982 the centre of the village has been protected however flooding still takes place in the Ings area.

There is one primary school in the village, one church and one shop/post office.

The charm of Cawood is its unspoilt character.
