Yesterday I received a letter regarding the above. I went on to to read the core strategy document which left me none the wiser about what is to happen.

I do believe that it is the Councils intention to baffle ordinary folk with this gobbledy gook.

I am a resident of Kellington and we have the most basic of services but yet you still plan to give us "affordable housing", I translate this to mean, single parent families, asylum seekers, unemployed and all the E U coming here for work? all claiming benefits and no doubt breeding like rabbits and we have plenty of them already.
