

The range of studies will include:

- Growth Options in Designated Service Villages
- Market Town Studies
- Draft Green Belt, Development Limits and Strategic Countryside Gaps Report

We are also talking to Parish and Town Councils, local businesses and landowners/developers as well as community representatives and other local groups through workshops, to which it is necessary to restrict numbers to invitation only (you will have already know about those if you have been invited).

The findings of the studies and feedback from this focused engagement (via both the workshops and the internet) will inform the scope and content of PLAN Selby. A substantial amount of further work will also be undertaken in order to develop and test options for delivering the planning policies and site allocations for the next stage of Plan preparation. You will have further opportunity to participate in the preparation of the Plan early next year when the Council will publish its Further Consultation setting out preferred options.
