- believe that further work needs to be undertaken as part of the next review of the RSS and in work on the LDF to establish the environmental capacity of York.
- 5.34 The Scenario B (2003-based) forecast for South Yorkshire for 2016 21 is 4830 annual provision (rounded up) compared with 4080 in Table 13.1 of the Plan. This is some 750 more dwellings a year. However we see in BP2 Appendix 4 that the adjusted figure for the South Yorkshire authorities is a 5080 annual provision for 2016 21, some 250 dwellings a year above Scenario B forecasts. This provision equated to the Local Planning Authority requests or comments. In order to foster the economic success of the Sheffield Sub Area (City Region) we recommend the Scenario B projections for the four South Yorkshire authorities for the period 2011 21. We consider that the breakdown by authority should reflect the proportions in the adjusted figures given in Appendix 4 of BP2 (page xix) and these are shown in Table 5.3 below.
- Leeds is recognised in the Plan as the major engine in the Regional economy 5.35 (Policy LCR1) and the desired outcome is to spread the benefits of a strong economy equitably through the City Region (paragraph 6.24 of the Plan). We consider that this should be reflected by adopting Scenario B (2003-based) for the West Yorkshire Sub Region local authority housing figures. Unfortunately unlike other Sub Regions we have less evidence on which to allocate this total amongst four of the five local authorities - not least, relevant information on land supply The exception is Calderdale where we consider the and availability. environmental constraints give weight to recommending the Plan's 2016 - 21 allocations for the period 2011 - 21. One possibility is equating this to the (set out RPIC in full) RPIC or LPA requests as in the South Yorkshire recommendation. However the Scenario B total is some 1260 dwellings per year above the RPIC proposals and 4200 above LPA requests for the four authorities. We are therefore restricting our recommendation to an overall total for the four Districts and leave GOYH to recommend the proportions between local authorities in the Secretary of State's Proposed Changes to RSS, taking into account the underlying objective of the Plan to achieve a closer balance between the distribution of housing and the growth in employment - particularly in Leeds; and the Panel's recommendation that the Sub Regional role of Bradford should be enhanced (see also paragraphs 5.118 - 5.130 below).
- 5.36 Finally, we sympathise with GOYH's view concerning housing provision to 2026 but consider that we do not have the evidence or resources to recommend net housing provision figures to 2021 26. All of this points to an early review of RSS to give local planning authorities in the Region a basis for LDDs for a 15 to 20 year period.

5.37 To summarise:

- the housing provision figures in the draft RSS (Table 13.1) for the period 2004 2011 should be retained,
- the housing provision figures in RSS should be the same for both the periods 2011-2016 and 2016-2021,

- the housing provision figures for 20011 2021 for the Humber, North Yorkshire, apart from York, and Calderdale should be the figures in the draft RSS for 2016 - 2021 (Table 13.1), and
- the housing provision figures for West Yorkshire (except Calderdale), South Yorkshire and York should more fully reflect the ONS/Scenario B projections. These are out in Table 5.3 below.
