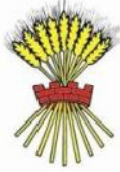

1. Non-Technical Summary

Introduction

- 1.1 A Non Technical Summary of the Helmsley Plan Main Modifications Sustainability Appraisal Report has been prepared to provide an overview of the assessment, in line with the requirements of Annex 1 of the Strategic Environmental Assessment (SEA) Directive.
- 1.2 This Sustainability Appraisal of Main Modifications report provides a supplement to the Final Sustainability Appraisal Report submitted alongside the Helmsley Plan in May 2014.

Context and Legislation

- 1.3 The Sustainability Appraisal Report (January 2014) considers in detail the requirements of the SEA Directive as listed below, although they are also considered as an integral part of the assessment in this supplement:
- Collection and presentation of baseline information;
 - Prediction of significant environmental, social and economic effects of the plan and addressing them during its preparation;
 - Identifying reasonable plan options and their effects which fully consider sustainable development;
 - Involving the public and Authorities with social, environmental and economic responsibilities as part of the assessment process;
 - Monitoring the actual effects of the plan during its implementation.

Sustainability Objectives

- 1.4 The objectives used to assess the sustainability implications of the proposed Main Modifications are listed below. These were developed and refined as part of the Scoping Report (May 2013):

Social Objectives

- A1 To ensure that all groups of the population have access to health, education, leisure, green infrastructure and recreation services that are required
- A2 To provide the opportunity for all people to meet their housing needs
- A3 To improve overall levels of health and reduce the disparities between different groups and different areas.
- A4 To maintain and promote the distinctiveness of identifiable communities
- A5 To reduce crime and the fear of crime
- A6 To develop a more balanced population

Economic Objectives

- B1 To maintain and enhance employment opportunities
- B2 To maintain and enhance the vitality of the countryside, villages and town centres
- B3 To retain and enhance the factors which are conducive to wealth creation, including personal creativity and attractiveness to investors
- B4 To diversify the local economy

Environmental Objectives

- C1 To protect and enhance biodiversity and geo-diversity.
- C2 To maintain and enhance the quality and character of the landscape, including the special qualities of remoteness and tranquillity
- C3 Reduce long distance commuting and congestion by reducing the need to travel.
- C4 To ensure future development is resilient to climate change such as development is not vulnerable to flooding, or will increase the risk of flooding elsewhere
- C5 To conserve and where appropriate enhance the historical and cultural environment
- C6 To reduce the emission of greenhouse gases
- C7 To encourage the use of renewable resources and the development of renewable energy sources within Ryedale
- C8 To make the most efficient use of land
- C9 To maintain a high quality environment in terms of air, soil and water quality
- C10 Ensure that fossil fuel and water consumption is as low as possible, protect productive soils and maintain the stock of minerals
- C11 To reduce the amount of waste produced and maximise the rates of re-use and recycling as locally as possible
- C12 To promote high standards of design which enhance the built environment.

Conclusions

- 1.5 Overall, the proposed modifications have been found to have mainly positive effects on sustainability objectives arising from greater certainty in relation to the provision of net gains in bio diversity and green infrastructure as well as more robust policies on the provision on telecommunications infrastructure. These will have positive effects on objectives to protect the natural and built environment.
- 1.6 The only potential negative effect arises from the removal of the requirement for the provision of bungalows, however on balance Policy H1 is still considered to have a positive impact on the provision of local housing needs and balanced communities.

2. Introduction

- 2.1 Sustainability Appraisal and Strategic Environmental Assessment are required to be undertaken in conjunction with the preparation of Development Plan Documents to ensure that the environmental, social and economic issues are fully integrated into emerging policies and strategies prior to their formal adoption.
- 2.2 This Sustainability Appraisal of Main Modifications report has been produced following the Helmsley Plan Examination hearing session which took place on 3rd March 2015. This provides a supplement to the Final Sustainability Appraisal Report submitted alongside the Helmsley Plan in May 2014.
- 2.3 Main modifications have been proposed at three stages – at Submission Stage in response to address issues raised through the Publication consultation, before the hearing session in response to the Inspector’s Initial Appraisal and now following the hearing session. A further Sustainability Report is therefore needed to ensure that the potential social, environmental and economic effects of the proposed Main Modifications are fully assessed for any significant sustainability impacts and reported on as part of the Plan making process.

Sustainability Appraisal Background

- 2.4 This Sustainability Appraisal report assesses significant changes that have not been assessed previously through the Plan preparation process. The report should therefore be read in conjunction with the following documents:

Draft Sustainability Appraisal Scoping Report (January 2012)
Final Sustainability Appraisal Scoping Report (May 2013)
Helmsley Plan Publication Version Sustainability Appraisal Report (January 2014)

- 2.7 These sustainability reports have been prepared in accordance with Government guidance on Sustainability Appraisal and incorporate the requirements of the Strategic Environmental Assessment Directive 2001/42/EC. Appendix 1 of the Proposed Submission Sustainability Appraisal (November 2013) shows how the requirements of the SEA Directive have been met. Appendix 1 of this document updates this to show how the Sustainability Appraisal of the Main Modifications meet these requirements.
- 2.8 A Screening Assessment and Appropriate Assessment was prepared separately under the requirements of the Habitats Directive (92/43/EEC) and was submitted to the Inspector prior to the Examination. The effects of the proposed Main Modifications on this assessment is explained in a further report on the Habitats Regulations Assessment.

Consultation

- 2.9 Representations may be submitted in relation to the Sustainability Appraisal of the proposed Main Modifications, as well as on the modifications themselves.
- 2.10 The consultation is running for a period of 6 weeks from 18th March to 29th April 2015. This is a formal stage of consultation. Further details of how to respond to the consultation are available at:

3. Appraisal Methodology

- 3.1 The Sustainability Appraisal of the proposed Main Modifications has been undertaken in two stages.
- 3.2 Firstly, each of the Main Modifications has been assessed to determine whether the modification raises any sustainability issues and whether a further appraisal is required. Where it has been concluded that an additional appraisal is required, the appraisal has been undertaken using the methodology below:

Considering Alternative Options

- 3.4 Part 6 of the Publication Sustainability Appraisal explains the role the Sustainability Appraisal has had in assessing options as part of the production of the Helmsley Plan. The Proposed Main Modifications do not propose any new options.

4. Proposed Main Modifications

- 4.1 The authorities have finalised the schedule of Main Modifications following the hearing sessions prior to receipt of the Inspector's interim report. These modifications address issues raised by the Inspector through his initial appraisal in July 2014, together with further changes proposed by the authorities.
- 4.2 The sustainability implications of the proposed Main Modifications are set out in full in Appendix 2. The summary below takes account of the initial assessment of sustainability implications and signposts those modifications that require further sustainability appraisal as a result of this initial assessment. It also sets out why further sustainability is not required for certain proposed Main Modifications.

Assessment Results

- 4.3 This section summarises the outcomes of the appraisal of those main modifications that were identified as requiring further assessment. The initial assessment in Appendix 2 and summarised in table 1 above determined which of the proposed main modifications were likely to have sustainability impacts and required further assessment. The full details of the assessment are shown in Appendix 3 and a summary of outcomes and potential effects is provided below.

MM7 Delete reference in Policy H1 to requirement that at least 5% of all new dwellings of more than 50 units must be bungalows

The proposed modification seeks to remove the requirement for the provision of bungalows on large sites. Although the removal of this requirement could have a negative impact on sustainability objectives which seek to meet a mix of housing needs and balanced communities, in practice the requirement would only apply to one site. On balance the whole of policy H1 will seek to provide a mix of housing to help sustain a mixed community and therefore is considered to still have positive impacts on objectives in terms of the overall Sustainability Appraisal.

MM26 and MM27 Amend Policy H11 to strengthen requirements in relation to net gains to biodiversity and green infrastructure.

The modifications relate to requirements for net gains in biodiversity and green infrastructure seeking to provide further clarification on how policy H11 will be applied through the Development Management Process. The change to the policy is considered to have positive impacts by seeking improvements to the provision of green infrastructure and biodiversity.

MM30 – amendments to the IT and telecommunications policy

The modifications will have positive impacts on sustainability objectives as it now addresses the wider landscape and historic environment rather than just the National Park so now has a positive impact on objectives C2 and C5. The modifications also seek the removal of redundant infrastructure, which again will have positive impacts on the Sustainability Objectives.

5. Conclusions

- 5.1 Overall, the proposed modifications have been found to have mainly positive effects on sustainability objectives arising from greater certainty in relation to the provision of net gains in bio diversity and green infrastructure as well as more robust policies on the provision on telecommunications infrastructure. These will have positive effects on objectives to protect the natural and built environment.
- 5.2 The only potential negative effect arises from the removal of the requirement for the provision of bungalows, however on balance Policy H1 is still considered to have a positive impact on the provision of local housing needs and balanced communities.

6. Monitoring

- 6.1 The Sustainability Appraisal Monitoring Framework is set out in Section 7 of the Sustainability Appraisal Report on the Helmsley Plan and will monitor the implementation of the Area Action Plan to identify any significant effects. No modifications are proposed to these indicators.

Consultation Requirements

- Authorities with specific environmental responsibilities; shall be consulted when deciding on the scope and level of detail of information which must be included in the environmental report (Article 5.4);
- Authorities with environmental responsibility and the public shall be given an early and effective opportunity within appropriate time frames to express their opinion on the draft plan or programme and accompanying environmental report before adoption of the plan or programme or its submission to the legislative procedure. (Article 6.2)
