#### STATEMENT OF COMMON GROUND ON THE LATEST POPULATION AND HOUSEHOLD PROJECTIONS

1. The following statement provides an explanation of the latest population and household projections and concludes by setting out the 2011-based interim alongside the 2008-based projections for Selby.

#### 2011 based interim sub national population projections<sup>i</sup>

- 2. The 2011 based interim population projections are based on the 2011 mid-year population estimates published on 25 September 2012 which are rolled forward from the 2011 Census.
- 3. Assumptions about future fertility, mortality and migration levels are based on the trends calculated for the 2010-based subnational population projections. They have been projected ten years ahead to 2021 and published for each English region (formerly Government Office Region), county and local authority (LA) by single year of age and sex.
- 4. Projections are not forecasts and take no account of policy nor development aims that have not yet had an impact on observed trends. The interim 2011-based subnational population projections for England provide an indication of the possible size and structure of the future population, based on the 2011 mid-year population estimate and the continuation of estimated trends used in the 2010-based projections.

#### 2011 based interim sub national household projections<sup>ii</sup>

5. The household projections are produced by applying projected household representative rates to the population projections published by the Office for National Statistics. Projected household representative rates are based on trends observed in Census and Labour Force Survey data. The assumptions underlying national household and population projections are demographic trend based. They are not forecasts as they do not attempt to predict the impact that future government policies, changing economic circumstances or other factors might have on demographic behaviour. They provide the household levels and structures that would result if the assumptions based on previous demographic trends in the population and rates of household formation were to be realised in practice.

### Comparison with previous projections<sup>iii</sup>

6. At the aggregate level the 2011-based household projections show a lower growth in households compared with the 2008-based projections, equating to 24,900 fewer households per year between 2011 and 2021 in England. This is despite the fact that adult household population growth is larger under the 2011-based projections than the 2008-based projections. The difference therefore largely reflects lower household representative rates (household formation) compared with the previous projections. The outcome of this is that the average household size in the 2011-based projections decreases at a slower rate than in the 2008-based projections.

- 7. Comparing the 2008-based and 2011-based projections for Selby illustrates the impact of lower household representative rates. As shown in Table 1, population change between 2011 and 2021 is about the same under both projections, but average annual household growth drops from 535 to 460.
- 8. Projecting forward from 2021 can only be undertaken once a view is taken on the impact of future policy and economic growth on household formation.
