¹ This timetable (local development scheme) was brought into effect by a resolution of <u>Craven District Council's Policy</u> Committee on 7th December 2017.

² Supplementary Planning Documents (SPD) build upon and provide more detailed advice or guidance on the policies in the local plan, without unnecessarily adding to the financial burdens on development.

³ The initial phase of creating a new local plan involves discussion with stakeholders, gathering evidence, honing in on critical issues and considering options. This may include preparing and consulting on one or more pre-publication drafts.

⁴ A final draft of the local plan is published for a 6-week period of formal public consultation and is then submitted to the Planning Inspectorate for an Examination in Public (EiP), at which the soundness of the local plan is tested.

⁵ The local plan may be adopted (brought into use) by a resolution of the full council, following a successful EiP.
