

This table is a summary table for the Sustainability Appraisal (SA) which takes into account the proposed Main Modifications arising from the examination of the Craven Local Plan. It lists each policy, whether it is modified by a Main Modification (and which one), whether it requires an update to the SA, and a summary of what the outcome is. The full updated iteration of the SA is also available to view for this local plan consultation. This iteration includes process descriptions of the SA processes for the spatial strategy, housing options, policies, and residential & employment sites.
